

Dear Parents,

Kinderfarm is in the process of determining enrollment for summer 2018 and the 2018-2019 school year. Please download and complete the main registration form (required for new and currently not enrolled students) and the `summer and/or fall registration forms and return them with the necessary deposits. Information concerning deposits can be found in the next paragraph. Families of children currently enrolled at Kinderfarm will be allowed to register for summer and/or fall classes before February 1, 2018. In order to guarantee a specific programming option for your child we recommend that you complete the registration forms and return them to Kinderfarm as soon as possible. A space shall be reserved for your child upon receipt of the registration form and required deposits. Registration forms for children not currently enrolled at Kinderfarm will be accepted on or after February 1, 2018. Parents will be notified via phone call when their child's registration materials have been received and the status of their enrollment request.

Kinderfarm will be offering a six week summer session and a five week summer session. The session dates are June 4– July 13 (six weeks) and July 16 – August 17 (five weeks). You may choose to sign up for a single summer session or both sessions. You are responsible for payment of all the weeks in the summer session(s) that you select. Each of the summer sessions require a non-refundable deposit of seventy-five dollars which will allow us to guarantee an accurate count of spaces available. Each seventy-five dollar deposit will secure a space for your child and will also serve as a credit to each session's tuition. If you are enrolling a child that does not currently attend Kinderfarm you must also include a fifty dollar registration fee.

Scheduling options and prices for the school year can also be found on our website under "Program Info". Registration forms for both summer and fall can be found on the "Enroll" section. Registration forms cannot be completed online.

Transportation to and from Kinderfarm is available for an additional charge. Rainbow Connections Limited is the sister company of Kinderfarm that provides the transportation services. Pricing for transportation services can be found at the bottom of the summer tuition schedule and the school year tuition schedule.

Kinderfarm does offer programming for children up to age seven that have attended elementary school. Space in the program is limited and available if enrollment makes it plausible.

The first day of the fall session will be Tuesday, September 4. Registration for the fall session requires a non-refundable deposit of seventy-five dollars. If you are enrolling a child that has not yet attended Kinderfarm you must also include a fifty dollar registration fee. The seventy - five dollar deposit will secure a space for your child and will also serve as a credit toward your September tuition bill.
